# Progress at the Boston interoperability meeting

The set of work packages was reviewed and confirmed; see the sections below for the surviving work-packages and the group Wiki-web page (<a href="http://www.ivoa.net/twiki/bin/view/IVOA/IvoaGridAndWebServices">http://www.ivoa.net/twiki/bin/view/IVOA/IvoaGridAndWebServices</a>) for more details.

The proposed work-package on workflow systems is considered out of scope for the group at present. It can either be reintroduced later, or can be the subject of a separate working-group. The GWS-WG meetings felt that workflow is too little understood at present to be the subject of standardization.

The group opted to retain the VOSpace work-package. This work could easily have been delegated to a new group, since it is self-contained. However, it was noted that the people expected to work on VOSpace are all participants in GWS-WG, so there is no real benefit in forming an extra group. Besides, VOSpace will act as a test of the group's single-sign-on profile; it helps to co-develop these two specifications.

# Work package: asynchronous activities profile

- At Boston, consensus that WS-RF would be a suitable infrastructure for this
  profile.
- Post-Boston, some concerns as to whether WS-CAF is better than WS-RF.
- Currently waiting for trade-off studies of WS-RF against WS-CAF

# Work package: single sign-on

#### Status:

- Consensus at boston on the use of digital signatures as the means of authentication.
- Fragile consensus at Boston on using community services inside the IVO as the basis for the PKI. Some concerns over the details have emerged.
- Uncertainties as to how the proposed system should be made interoperable with other systems, notably GSI and Shibboleth. The use of SAML in Shibboleth may be something our profile should adopt.
- Currently blocked, waiting for better understanding of interoperability issues.
