The new Euro-VO Registry offers you the following main functionalities:




For astronomers and end users:

Search the VO resources through the Simple Search Panel, the Advanced Search or through the expert ADQL Search Panel (click on the  icon).




For data publishers:

Host your resources with EuroVO, create and update your own VO Resources via a password-protected interface, check their compliance with the associated IVOA standards (click on the  icon; requires an account: click to join).



For VO Applications developers and for other IVOA Registries:

Harvest the registry, retrieve individual resources, or search the registry through its programmatic [OAI-PMH](#), [RI1](#) and [RegTAP](#) interfaces (click on the  icon to find more information).

Harvested registry resource anomalies

Anomalies discovered when examining the registry resource records as made available by publishing registries (and not as made available by the RoR)

RoR registry resource anomalies

Anomalies discovered when examining solely the representation of registry resource records as made available by the RoR.

RoR - harvested registry records discrepancies

Discrepancies between the registry resource records as made available by the RoR and as harvested by their respective registries

Other anomalies

Anomalies not falling into one of the other categories

Big improvement !

ROR-03 :: Common managed authority

Two different registry records as retrieved from the RoR contain a common managed authority

Anomaly count: **1**

#	Description
1	Registries 'ivo://esavo/registry' and 'ivo://idoc/__system__/services/registry' contain 1 common managed authorities: idoc

Potential Action to be taken:

- RofR to update the Euro-VO Registry resources

ROR-HRV-01 :: A registry record was harvested that was not also found in the RoR

A given registry IVOID is found in the local system database but not in the Registry of Registries

Anomaly count: **1**

Potential Action to be taken:

ROR-HRV-02 :: OAI-PMH / RoR registry info discrepancy

Discrepancy between the registry information reported for a particular registry resource by the Registry of Registries and the information obtained via the OAI-PMH protocol

Anomaly count: **2**

Registry Anomalies Report (SG-01)



SG-01 :: OAIPMH protocol failure

Network failure in the OAI-PMH protocol or failure to parse response according to expected OAI-PMH type when trying to access a particular registry during the production of this report

Anomaly count: **2**
