### Registry Session Summary (1/3)

#### 1. Hendrik Heinl: Time Series in the VO -- how not to be seen

- Demo showing the difficulty to locate TESS and Gaia lightcurves in the Registry
- pyvo.registry.search and TOPCAT give different results!
- A solution seems to bring ObsCore dataproduct\_types into the VODataService Registry records...

#### 2. Markus Demleitner - Confessions of a Registry Janitor

- The author runs and analyses the contents of one of the main Full Searchable Registries and has a variety of advice to share with publishing registry maintainers:
  - Use coverage to appear in Aladin's resource tree
  - Make author search easier by standardizing their name format
  - Be reachable through a long-term alias for the contact info (eg support@your.institute.edu)
  - Use the UAT Controlled Vocabulary (CV) for subjects (eg "abell-clusters")
  - Create useful resource descriptions
  - Use relationships (CV) between Resources (ex: data ServedBy -> a TAP service)
  - Describe tables and columns with UCDs using <tableset> (vs glots which might disappear!)

## Registry Session Summary (2/3)

#### 3. Markus Demleitner - Towards VOResource-1.2

- Adopting the Unified Astronomy Thesaurus (UAT) for Subjects: identifiers are now defined in <a href="https://www.ivoa.net/rdf/uat">https://www.ivoa.net/rdf/uat</a>
- rights and rightsURI should now point to a license from SPDX <a href="https://spdx.org/licenses/">https://spdx.org/licenses/</a>
- generalize altIdentifiers to point to non-VO resources such as DOIs or ORCIDs (only creator and contact in 1.1)

#### 4. Renaud Savalle - StandardRegExt -1.1

- Importance of registering IVOA standards
- Solutions for 4 problems raised by Markus at our last session (Oct22)
  - 1. How to register Endorsed Notes? => Add statuses "en" and "pen" to EndorsedVersion alongside "rec", "pr", etc.
  - 2. Which standards to register? Important change: "Only IVOA standards that actually make use of identifiers to or into StandardsRegExt records MUST be accompanied with active records published by the ivoa.net registry. " => in particular all standards defining capabilities to be discerned using their standardID attribute
  - 3. Deprecate StandardKeyEnumeration in favor of Controled Vocabularies managed by the Semantics group
  - 4. Authors of standards should define how standard keys should be updated.

## Registry Session Summary (3/3)

#### 5. Discussion

- Deprecate Registry RI1.0 client search functionality and only keep the relational backend
  - RI1.0 client search only seems to work at EURO-VO Reg, where it is only used internally
  - WG planning to send a warning msg on the ML then switch off these servers and client features
- Status of RegTAP-1.2 implementations
  - GAVO Heidelberg + Paris mirror: DaCHS supports RegTAP-1.2 and MOC geometric queries
  - ESAC: update planned in 2024
  - NAVO: no committed resources
- Report of curation efforts in progress
- Validation: re-appropriate the RofR code and implement single-record validation
- New service to re-harvest a publishing registry (talk planned at next registry session)
- Need for maintaining machine-readable validators list (but not in the Registry!)

## Registry in other Sessions...

- "Need for the Registry to become more transparent and data vs service-oriented"
- "Users should not have to worry about the VO stds"?
- Better describe/introduce/teach the publishing registry maintainer business with EDU IG
