5. USVOA Organization update

GF highlighted that the US Virtual Observatory Alliance (USVOA) was set up as a Special Interest Group (SIG) of the AAS Working Group on Astronomical Software (WGAS), aimed at ensuring full participation of the US astronomical community in the development and implementation of VO standards.

The USVOA has appointed Pepi Fabbiano (SAO), Bruce Berriman (IPAC) and Brian Glendenning (NRAO) as US delegation to the IVOA Exec.

6. TCG Status

SG reported a TCG telecon was held on May 12 in preparation for the Sesto Interop. The face-to-face TCG meeting was held on Jun 14. He thanked TCG members that will be turning over for their contributions.

For Standards, Datalink 1.0 is before the Exec for Recommendation. Several other standards are at various phases of the process. Details are available in the meeting report page:

Summary of Topics discussed by TCG:

- Web Assets (as per Exec ACTION TM-56-3)
 - Mailing lists
 - Decision to make WG/IG chairs and vice-chairs responsible for moderating their respective mailing lists.
 - o Document repository
 - Currently have inconsistent document paths. Action to flatten the document directory to remove inconsistencies.

- Validators/Registries
 - Registered services that don't respond and the publishers that don't respond to emails.
 - Need a policy to "clean up" the registry; impacts validators
- Reference Implementations and Validators
 - Reference implementations and validators early in the process, i.e., before RFC as feedback from implementations can help improve the WD.
 - A "chicken and egg problem": implementers of standards often wait for a PR or a Rec before beginning work when it is too late to feed back information gained.
 - It could be a TCG function to evaluate reference implementations and validators as part of the Recommendation process.
- Recommendation Process
 - Some things not functioning: late comments, lack of reference implementations, compliance checking and use cases
 - $\circ~$ Standards and Processes committee to be asked to review the recommendation process with input from TCG
- Volute replacement
 - Volute/Google Code repository end of life August 2015
 - Recommendation to Exec to request a free organizational account from GitHub.
- IVOA schema evolution
 - Discussion at this InterOp. If solution is agreed upon, a Strong Note will document the solution.
- Errata
 - Agreed to have "Accepted Errata" page for standards separate from proposed/rejected errata page.
 - Agreed that the "Accepted Errata" page be reviewed by the TCG and endorsed by Exec.
 - MD will send the revised proposal to go to Standards and Processes committee.

Added as a discussion topic at the Exec Wed supplementary meeting on:

• Volute replacement, Registry 'clean up'.

The current (as of Jun 08) IVOA recommendation under review by the Exec is Datalink 1.0. CA has received 14 positive responses so far and encouraged anyone who has not responded to do so before Wed, Jun 17 when a decision on the recommendation will be reached by the Exec.

9. Registry of Registries (RofR) transfer from NCSA

GF expressed interest on behalf of the USVOA for the SAO/CXC group to take over the RofR from NCSA. The CXC currently maintains a publishing registry and is in the ready to

migrate the RofR implementation from NCSA to SAO and to maintain the RofR service in the US. The Exec endorsed the transition to SAO/CXC.
