4. Project Reports [Significant Events Only]

JJK reported about the effort of organizing the 2022 Fall interop Meeting the week before ADASS in Victoria in September 2022. The plan had been for this meeting be 'hybrid' with in-person and remote participation. During discussion with the host hotel CVO determined that CVO would be exposed to about a \$100k liability if the meeting needed to move to 'on-line' only. CVO is not able to accept this liability. Three options are presented:

- The Fall 2022 meeting be planned as on-line only.
- The IVOExec members agree to share this liability and we have some complex cost sharing arrangement.
- We move the Fall interop to a different location that is more able to mitigate the risk and liability

The Exec decided to hold the meeting virtually.

5. TCG Status

- Ongoing RFC:
 - o Group membership services (PR-GMS-1.0) Working on RFC comments
 - EPN-TAP (PR-EPB-TAP-2.0) some final discussion on the doc going on; close to TCG vote
 - SimpleDalRegExt (PR-SimpleDalRegExt-1.2) TCG comments ongoing; seems in good shape
 - o MOC (PR-MOC-2.0) in RFC phase close to TCG vote
- Other:
 - TCG met last on Dec 01; next meeting is Jan 26, 2022
 - o KDD V Chair a vice chair is needed for this group to start some activities; Exec needs to take some actions in looking for a possible candidate for this position.
 - Roadmaps for 2021A in great shape. Multiple groups have included their inputs.

 - TCG suggests the Northern Spring 2022 Interop dates be set early as the fall meeting will be preceding ADASS in early September (7 to 9). → Exec agrees on the week of April 25th
 - o Code of Conduct for the IVOA & Certificate of Origin:
 - The code of conduct (circa 2020) could be more visible and the Exec agrees on the TCG suggestion to include the link to the document on the IVOA meeting registration page for future Interop meetings.
 - A Certificate of Origin is common practice for publicly available software/docs.
 A Certificate of Origin has been drafted and put in the GitHub repository for review and comment by the TCG

 Publishing in the VO: The group met on Dec 10, 2021 (Ada, Marco, Henrik, Francois, Janet) and is forward planning for May Interop & Newcomers session. → BB reports that some IPAC colleagues that attended the last Newcomers session have some inputs and comments for improvements.

7. Future Interop meetings

9. Developing a strategy for engagement with the IAU (BB)

As there was not time to present and discuss this item during the meeting, BB followed up the meeting with an email on the same day to the Exec. The email is reported below. This item will be discussed more at the next Exec meeting.

From BB email to Exec on 12/15/21

As you know, our proposal to form a Functional Working Group of Division B of the IAU, called "The Virtual Observatory," was accepted. Since then the IAU has set up a web page for the WG at: https://www.iau.org/science/scientific bodies/working groups/336/

I have attached for reference information on the purpose of the WGs.

About two days after the WG was approved, there was a call for presentations at the IAU "Division Day" meeting at the General Assembly in August. With help from Ajit, Chenzhou and Mark, we are scheduled for two talks: Science With The IVOA, and IVOA and FAIR principles. Mark and I will give these presentations. The meeting is planned as in-person, but of course that may change. We are also participants in the Lab Astro WG, and last year we signed the MoU between ourselves and IAU OAD.

We were quite brusquely rebuffed by "I-HOW IAU Hands On Workshops," who are now soliciting proposals for workshops, despite brave efforts by Pat Whitelock to secure our engagement. We were told we were free to submit a proposal to host a workshop. I had pointed out several times before that we have no funding to sponsor meetings but would like to support the enterprise. I think an important topic for us in 2022 will be to establish a strategy for engagement in the IAU. Janet suggested that we hold a session at the May interop, and this is likely a good venue for the topic, though I do think the Exec needs to have prior discussion on strategy.

10. IVOA and Blockchain Open Development protocols (SG)

SG gave a 15 minutes presentation on the subject. The presentation can be found attached on the TM102 page (still waiting for the presentation).

The Exec reminded to SG that all IVOA standards are being driven by a science case and they do not see yet such case presented by SG.

ACTION: BB and Exec will provide feedback via email to SG about this subject.
