Discussion

- 1. Roll Call and Agenda
- The names of the attendees are recorded.
- 2. Review and Approval of TM120 & TM121 Minutes
 - PF puts forward the motion to approve the minutes.
 - BB seconds the motion.
 - The minutes are approved.
- 3. Review of Exec Actions for TM122
- **TM119.1:** MM will ask those who are already working on the website if they want to be in the Media Group. **DONE**
- **TM119.2:** SO to send out another email before Interop inviting participants, with a more thorough description of the Media Group and its goals. **DONE**
 - o At Interop, Exec resolved to have newsletter editors to do this work.
 - FC and two other people have volunteered to work on the newsletter. They will need to arrange the mailing list.
- TM119.7: SO will send out a summary of costs and contributions for Malta Interop. DONE—to be discussed later in this meeting.
- TM120.1: SO will request a deadline extension for the SPIE poster and manuscript; he'll also send out the abstract to Exec. IN PROGRESS—extension granted; SO will send around a draft of the manuscript.
- TM120.2: CA to investigate if registry statistics per country could be reported for planning Spring 2025 Interop at UMD in College Park, Maryland (USA). IN PROGRESS
 - Discussed at registry sessions in Sydney. This information is not systematically collected. CA would like to leave this action open. Additional discussions will be required to see if this is possible.
- TM121.1: SO to speak with Anne and FC about Northern Spring 2025 Interop. DONE
 - In principle, there is agreement the meeting can be hosted at College Park, Maryland, but it's subject to venue availability. FC will follow up with Anne and other contacts to kick off discussion.

4. VO session at IAU General Assembly

- BB: If you're attending the General Assembly, please attend our session on Aug. 12 at 12:30 p.m. MA is one of the speakers.
- Gabriele Giovannini was happy to see we got speakers who were not part of the VO, which is what they want.

5. What to do about I-HOW?

BB has invited people to the IAU session and pointed out the commonalities with data access, data discovery, etc. They didn't seem very interested in engaging with us. They have extended an invitation to submit a talk, but the workshops are extensive—lasting a couple of weeks—and there isn't enough time. They also require that all speakers are lined up.

- BB is not well acquainted with the I-HOW contacts. They are astronomers, but not people he knows. SO is acquainted with someone on the list; he could reach out to them.
 - PF suggests reaching out and getting to know them better.
 - PW voiced concern that some people have a very negative view of the IVOA.
 Maybe talking would help.
- BB has asked MA to take a lead in interacting with the organization. MA said he'll
 endeavor to intersect with them if possible. MA has reviewed the workshops, there are
 5-7, and they dive deeply into very niche topics, like a specific instrument. IVOA doesn't
 really fit into the way they're organized. We could just submit a proposal with extra
 funding and at least eight people available, which is a lot.
 - BB said if we want to try to submit a proposal, we need about a year's lead time.
 This came about because Debra Ellmegreen asked Gabriele Giovannini to be in touch with us.
 - BB said a professional conference organizer is needed for something of this scale.
- PF asked who are these people?
 - BB their associations are major astronomy sessions like HEASARC, Groningen, etc., but their charter may be different from the IVOA. SO notes their selection process is long and rather odd. You can email any member of the committee to start the process; there is no central membership email.
 - o PF: Their aim could be different than us.
 - SO: The flavor of the previous workshops has been high-level: high-res transmission spectroscopy, etc. There is a lot of criteria around the hosts. Love the idea of it but agree with MA that a lot of planning is required.
- BB said they give you €12000.
 - MA: Consider it costs around €30-40000 for a two-week event. There is an opportunity here, but it will require other resources. The travel cost of bringing the speakers to the location would be very high.
- Exec will hold off on deciding whether to submit a proposal until more info is gathered.

- Action: MA will contact people from I-HOW Initiative in person at the IAU General Assembly.
- 6. Should BB continue as IAU VO Functional Group Chair?
 - BB said he will do this if we want him to. He received an email from the secretary noting that Chairs are limited to three years, but it's a functional WG so the term is actually six years.
 - SO is fine with BB continuing. No objections from the rest of Exec. Other members of the WG are CC, SG, AM, and PW, though SG resigned from Exec so he will need to be replaced.
 - Action: BB will look for a replacement for SG for the IVOA-IAU WG
 - MM: Side note: There is a Twiki page listing the groups, etc. The Liaison group is missing from the list. BB had asked Giulia to add it; it may have gotten lost.
 - Action: BB to follow-up with Giulia and cc: MM about adding Liaison group to Twiki.
- 7. Project Reports [Significant Events Only]
 - **VObs.it (Italy):** Working on the server for the "new" website. There is underground work going to keep VObs.it up and stable.
 - USVOA: BB said funding for the next fiscal for NAVO was approved.
- 8. Overall TCG Status
 - TCG met on 26 June
 - Restarting after Sydney Interop, getting settled with changes
 - RegTAP-1.2 & VOTable-1.5 in RFC review
 - VOEvent-2.1 should come up soon for RFC (PR first)
 - 2024A Roadmaps are being set up for the semester
 - DM/DAL/Apps/... joint session follow up
 - FITS serialisation
 - CAOM integration
 - NASA multi-order spectra community standardization effort
 - DCP non-VO standards listings
 - astronet.ru publishing registry issue: it has stopped responding since 2020 and no one in the contact list is responding. There is a proposal to temporarily remove the registry for now and see what happen. MM is asking Exec for a vote.
 - OM is familiar with astronet and knows the PI. If we have specific questions about astronet, he will contact the leaders. He's not in Moscow but he is in Russia.

10. CSP Status (report by FC)

- FC contacted Vandana Desai at IPAC; there is a meeting scheduled in two weeks to meet and call a CSP meeting.
- IVOA plenary in Malta: Determining whether to have a high-energy WG meeting there or postpone until the spring.

11. IVOA Website [new standing item]

 MM: Some back-end work going on. There was an SSH bombing during the Sydney Interop. MM just reinstated SSH now and put security measures in place to avoid another bombing. By next Interop, we should have some content built.

12. Future Interop meetings

- Northern Fall 2024: Malta— Week of Nov. 10 (ADASS Nov. 10-14)
 - SO sent Exec a very simple budget on the costs received from Malta organizers. For 100 attendees, it's probably at the higher limit based on post-Covid meetings, but given that it's attached to ADASS, it's hard to estimate. Costs are around €10000. Do we want to have a registration fee to cover the costs? Potentially a combination of partner organizations could provide financial contributions, e.g., €1000E each, plus a small registration fee per attendee. Another option is to never have a registration fee or always charge a fee. What do people think? We are a bit short on funds (about €1200) to cover the meeting costs.
 - MA prefers to look at it on a case-by-case basis. €50 is reasonable.
 - JJ: €50 is not substantive compared to travel costs. What is the collection mechanism and what will that cost? Can we piggyback on the ADASS process?
 - CA said we could have two registrations: ADASS and IVOA. It's cleaner, especially where fees are concerned. In the future, it's a bit easier if the reg fee would cover all of the expenses. It's strange for an organization to sponsor and also pay for people to attend.
 - What happens with surplus funds if we receive financial contributions and also collect reg fees?
 - CA said it might be too late to request a reg fee. He could probably raise another €500 to cover the gap.
 - MM said OV-France may be able to contribute more as well, but this needs to be checked with Simon, Franck, and Ada.

- Exec will continue seeking additional contributions with the goal to not charge a registration fee.
- SO: We wouldn't expect more than 100 people to attend Malta. For Sydney, there were 87 registered, but some people didn't come for various reasons.
- Action: SO to investigate meeting rooms at Malta.
- Northern Spring 2025
 - o Reg fee will not be needed because there will be local sources of funding.
