1. Roll Call and Agenda

2. Minutes from FM80

3. Review of Exec Actions

ActionFM80-1: MA – arrange for NASA/NSF representatives be invited to the IVOA Spring Interop **OPEN** – will contact Nigel Sharp, Linda Sparks in the New Year

ActionFM80-2: BM – Put bullets together on Portal and plan for a Focus session in May. Send info to Exec. **OPEN** – CSP planning meeting set for Dec 17

ActionFM80-3: CC – Invite to Data to Dome group to Paris meeting to present their work in a plenary session. They could bring use cases and then folks can evaluate the effort to existing standards. *Working* – Invitation sent

ActionFM80-4: CA – Meet with ADS and report back to the Exec. **DONE** – CA talked with AA; ADS will assign DOIs to IVOA standards

ActionFM80-5: MA – Name and definition of the WG; follow-up with M Wise - *Working*; *PW offered to help*

4. Project Reports [Significant Events Only]

BB reported that an AstroData 2020 Workshop was held in Pasadena Dec 4-7. The meeting was held to ensure that the Decadal Committee gets useful feedback regarding what will need to happen with archives in the 2020s. Of note it was agreed that the VO and IVOA are necessary for infrastructure in the coming decade. At the Jan AAS, there will also be a meeting of the Astrophysics Archives in the 2020's. For USVOA, there was a telecon and planning for the annual meeting. Plans are being formulated to present results and demos at the meeting.

5. Overall TCG Status

PD reported that the standards were in the same place as reported at the College Park meeting. There has been a new Publishing in the VO that Tom McGlynn put together. TCG members is working to populate the new page with plans for it to go live after review in the next month or so.

6. Approval of new IVOA Recommendation(s) [Standing Item]

7. Overall CSP Status

MA noted that a VO/Python hackathon was being planned for the Spring Interop and that BM had a CSP meeting planned in the next week to initiate planning. PD asked How long and How many people participating was being planned for. He said App/DM could be consulted to see how the session in Victoria went. PW said she thinks it is a good idea to interact with AstroPy. TJ noted that at the AstroPy Coordination Meeting last week there was talk about some of the VO standards. The hackathon will keep the positive momentum going.

BM who joined the meeting later added that the CSP telecon was planned for Dec 17. The main topic would be the Focus session/Hackathon at the May Interop. He also noting that engaging with the Astropy group was a continued focus.

8. Review terms up for expiration

The terms up for expiration were reviewed. The term that needed immediate action was the KDIG position. MA contacted Kai Polsterer prior to the Exec meeting and reported he was willing to serve the extension. TJ asked why the December term was out of sync with F2F meetings? The Exec agreed to an extension coming due at the Oct 2019 Interop.

9. Exec Secretary nominations

MA noted that there had been one nomination made in College Park by BB of a person in his organization (Marcy Hebert). The discussion lead to the suggestion that perhaps joining the Media Group would be a better first contribution to someone new who had interest in getting involved in the IVOA. MA announced that a nomination of Francesca Civano had been received from Pepi Fabbiano prior to the meeting. JE provided an overview of Francesca's participation in the IAU and IVOA meeting, her position at CfA/CXC, and her interests as an active scientist working on large surveys for Pepi who could not attend the Exec meeting. It was decided that it was necessary to give the full Exec time to consider this nomination. Some members also asked to have the possibility of providing other nominations. This will be followed up by email.

10. Future Interops

a. Northern Spring 2019 - Paris, France (May 12-17)

MA noted that an update to the Paris meeting was given at College Park and we should invite Baptiste to the next telecon so he can provide an update.

b. Northern Autumn 2019 - Gronigan, Netherlands (Oct11-13)
 i. Update from meeting at ADASS with Roberto Pizzo

MA highlighted that PD, JE, and himself met with Roberto Pizzo in Collage Park. Roberto was already planning to host IVOA in the Netherlands. The meeting would be after ADASS and held at a smaller venue. Roberto noted that support for the meeting was ~7500EU and made a request for supporting funds from IVOA member institutions. MA thought it may be prudent to combine additional IVOA monetary support as part of the ADASS contribution. MA suggested he would send an email and find out about that possibility.

c. Northern Spring 2020 - Sydney offer from Simon O'Toole

Simon O'Toole made an offer to host the Northern Spring 2020 IVOA meeting in Sydney. Though there was generally good support, there was also some concern about the funding for a distant trip and acknowledgement that the size of the meeting would most likely be smaller. MA wasn't sure when Simon would need an answer and offered to write an email expressing the concerns and if more time was available to decide.

He noted that the paper needed to be submitted before Christmas and that his plan was to circulate it to the Exec for comments when a draft paper was complete.
