2. The Minutes of TM95

3. Review of Exec ACTIONS

4. Project Reports [Significant Events Only]

CVO: CADC has placed a deposit on the venue ADASS-2022 in Victoria. We are working with University of Toronto and University of Victoria to host this meeting. Due to long-lead times for conference venues the ADASS-2022 <u>LoC</u> is requesting details on possible IVOA Interop attached to ADASS-2022 (including possible executive session).

CVO will be pursuing 'CoreTrustSeal' certification within a cohort of Canadian data repositories that are moving through this process together. Expect CTS process to finish by end of summer 2021.

BB: NAVO is organizing a workshop on VO services in NAVO archives at the summer AAS meeting.

MA: Online VO summer school organized as part of the ESCAPE project.

FP reported that, within the revision of all INAF projects promoted by the new President, VObs.it will be proposed as a "programme" (long-term project), coordinated and funded by INAF with the formal participation of ASI and possibly some Universities.

7. Future Interop meetings

The meeting will be held the week of May 24th (between two holidays in France and in the US).

JE: What is the role of a virtual meeting host?

Usually for in person meetings the sponsor takes care of logistics, refreshments and meals and accommodations but for an online meeting it is different as this organization is not needed. It would be nice to have a sponsor helping possibly with side and breakout rooms to allow for small and separate meetings beside the general meetings.

The IVOA Northern Fall Meeting will happen after the ADASS. Currently ADASS is scheduled for November 2-4, 2021.

PW: The ADASS, supposedly was going to be held in South Africa and it will be fully virtual or partially face-to-face with just the local people attending in person. This will solve the issue of the time zones as it will happen in SA local time to accommodate the people attending in person.

The date for the IVOA Northern Fall Meeting will be discussed at the next TCG meeting.

8. CSP Charter revision

New CSP charter was circulated on Feb 22nd for comment to the Exec. The Exec agrees unanimously on the new charter and fully endorses it. Everyone voted in favor of the revision.

ACTION: BM will send the new charter to CSP and eventually to Interop list.

9. MoU between IVOA and OAD

The MoU between IVOA and IAU OAD was prepared by the Education IG. The document was sent to the Exec for comments on Feb 22nd, 2021. The Exec agrees unanimously on the MoU and fully endorses it.

ACTION: CC will sign on behalf of IVOA. **ACTION**: CC will circulate it to Interop list.

14. GORC International Benchmarking WG Case Statement (FLP, FG)

FG presents that the RDA has an Interest Group about Global Open Research Commons (GORC). They explain that the realized vision of GORC will provide frictionless access to all research artefacts including data, publications, software and computing resources, metadata, vocabularies, and identification services. This Interest Group is proposing a GORC International Benchmarking Working Group, in which they want to deal with pannational, national and domain commons. The IVOA is cited among the domain commons. It is likely that the WG will be accepted. I send this message to the Exec because I think that the IVOA has to be ready to provide input - I just posted a comment in the WG RfC in which I say (among other things) that I will inform the IVOA about the WG.

FG is a member of the WG and can act as a contact in this preliminary phase. It would be useful that other IVOA members also join, and for the Exec and TCG to follow what will be going on in this WG.

CC encourages IVOA members to self-nominate as Organizing Committee member for the IAU B2 commission. It is an important opportunity for the VO to improve our visibility among the whole astronomy community.
