

# Challenges



- For users...
  - Find services that don't exist or fail
  - Services that don't work properly
  - Can make workflows impossible
- For application developers...
  - Require good compliance
  - Not practically possible to filter on compliance
  - Registry compliance, consistency particularly important
- For data providers...
  - How do they ensure deployment of “good” services?
  - How do they (we) keep cost of “good” services low?
  - How do we encourage good registry descriptions



# Operational Strategies

---

- Making Validators widely available
  - Work: Building, Validating a Validator
  - IVOA Ownership of validating
  - Reveals problems with standards
    - Can we do errata/fast-track revision of standards?
  - Update and Discussion on Thursday
- Service Toolkits
  - General configure-and-play implementations of IVOA standard service protocols
  - Reduce cost, improve quality
  - Update and Discussion on Thursday



# Operational Strategies

---

- Monitoring Health of the VO
  - Snapshots of what's up
  - Periodic re-validation of services
  - Communication with publishers about problems
  - Update from Tom

# Registry Maintenance

- RegistryGuide Twiki
  - \_ To capture registry maintenance practices
  - \_ To capture recommended use strategies
    - Recommended queries (e.g. how to retrieve all SIA services)
- Registry Search interface validator needed
- Improvements in Publishing Interfaces needed
- Registry Issue Tracker
  - \_ Registry admins as members
  - \_ Track reported problems, special requests
  - \_ Coordinate inter-project resolution
- Registry Curation Practices
  - \_ ValidationLevel: rating of a Registry record's compliance and quality
    - Set by Registry curators according to local standards
    - Can be used by applications to filter for services
  - \_ Develop policies for rating resources via ValidationLevel
